Notes to Consider:

Out of the current 19 negative responses there are 10 Y5 parents. This is currently the class which has the lowest percentage of SEN, No EHCPs and therefore has limited behaviour issues when the class is covered by a HLTA.

Out of the 10 Y5 parent, 7 of them only have a child in Y5 and will therefore only have 1 more years at our school.

There are 5 Y4 parents, 2 of these have no siblings in school and will therefore leave our school in 2 years.

The other 4 are from a range of year groups.

4 of the votes are from parents in Foundation and Key Stage 1.

9 of the Parents are in Key Stage 2.

6 of the votes has children in both key stages.

Staff Consultation Results So Far (11.05.21)

The head teacher has not been provided with a vote in the consultation process. The consultation has been sent out to all staff employed by Meadow View Primary School: 8 teachers, 12 teaching assistants, 4 SMSAs and 3 admin staff and each person

employed by the school has a vote. Staff who work within the school but are not employed by the school (i.e. caretaker, kitchen staff and cleaners) have been informed of the consultation process but have not been permitted to have a vote.

Childcare

As childcare is a big issue that many parents have presented as an argument against, if we go ahead with the proposal, I feel it is an issue that we need to consider carefully and make the childcare as accessible as possible for parents. I have therefore run the following scenario as I feel that this would provide some thoughts as to what costs would be incurred by parents for 2 hours Friday afternoon care.

Scenario 1

25 Children F2 - Y6

2 members of SMSA staff paid for 2.5 hours

Children to access care 1:15pm - 3:15 pm

To cover costs incurred to school we would be looking to charge £ 2.64

Scenario 2

10 Children F2 - Y6

2 members of SMSA staff paid for 2.5 hours

Children to access care 1:15pm - 3:15 pm

To cover costs incurred to school we would be looking to charge £6.65

Scenario 3

Up to 25 Children F2 - Y6

2 members of SMSA staff paid for 2.5 hours

Children to access care 1:15pm - 3:15 pm

School could cover the costs of £2593 per annum

Scenario 4

25 Children F2 - Y6

2 members of SMSA staff paid for 2.5 hours

Children to access care 1:15pm – 3:15 pm

Nominal fee of £2 per family and School cover the additional costs of £643 per annum

In all scenarios school would cover the costs of materials used for crafts and activities.
